### Submitting Your Report

Firstly, we suggest that you do not enter the whistleblowing app website via the link provided by the organization. The organization usually publishes this link on its homepage or intranet. In order to increase your protection, copy the address of the whistleblowing web-site or bookmark it and enter the web-site directly.

Once you have entered the web-site, you can start submitting your report by clicking on the “Make a report” button.



**Make a report**

The report should be made in good faith. Please note, mandatory questions are marked with an asterisk (\*) and you will not be able to proceed without filling in the respective fields. After submitting the report, your username and password will be automatically generated and displayed on your screen. Please write them down as you will need them to enter your inbox and follow up on your report.

In the next step you will find information on how to use the application in a secure way and how the submitted data are being processed.

You need to confirm you read and understand the provided information by ticking the box in order to proceed.



**Secure usage of the application**  
If you do not wish to reveal your identity, be careful not to submit any information that may personally identify you. Check whether your internet connection is safe and the browser you are using, displays a padlock icon. Enter the application directly by saving the entry page to bookmarks.  
ABC Transparency GmbH guarantees the technical anonymity of the reporting person and ensures that his/her identity cannot be traced by technical means.

**Data processing**  
The organization is the controller of the submitted personal data.

**Reporting a breach**

For successful processing of your report it is important to provide as much information on the subject matter as possible. Mandatory questions are marked with an asterisk and you will not be able to proceed without filling in the respective fields. Information provided in non-mandatory fields is most welcome, however, you can skip these fields if you do not have the relevant knowledge.

Please note that any reported person may be notified of the report at an appropriate time by the organization.

**Attach documents**

Prior to their attachment, check your files for metadata that may reveal your identity. We recommend sending the documents in a pdf format or in paper to the address of the organization and writing your username which will be assigned to you upon completion of your submission.

At the end of the process, you will be asked whether you wish to disclose your identity. If you want to remain anonymous, just click on the "Submit" button.

**Reporting a breach**


You may submit your report anonymously, or you may decide to disclose your identity to the organization either now or even later. In both cases you will be assigned a username and password, which you will need to access your inbox.

Disclosed ID of the reporting person usually allows for a more productive and efficient processing of the report and his/her protection against retaliation. Please refer to the organization's policies for further details on protection against retaliation and confidentiality.

If you decide to identify yourself, you will be able to enter your details into the fields on the next page. The fields with asterisk are mandatory.

You will receive a confirmation of the receipt of your report to the email address that you enter in the dedicated field.

By ticking the box in the bottom of the page you can activate the option to be notified via email of any messages from the organization that are waiting for you in your inbox, provided you entered the email address, of course.





### Accessing Your Inbox
